

The City Council met in regular monthly session pursuant to adjournment at 4:30 o'clock P.M. on June 5, 2017. A quorum was declared by Mayor Deb De Haan. The meeting was held in the Council Chambers, City Hall, 125 Central Ave SE, Orange City, Iowa.

Approval of Minutes: The minutes of the May 15, 2017 and May 26, 2017 council meetings were presented.
