Resolution in Support of a Workforce Housing Tax Incentive Program Application to be submitted to the Iowa Economic Development Authority: Vision Builders would like to apply to the Iowa Economic Development Authority for Iowa Workforce Housing Tax Credits. They are applying for tax credits to construct a six-unit townhouse and a two-unit condominium in the Puddle Jumper 8th Addition. A motion was made by Council member Chad Oolman and duly seconded by Council member Rod De Boer adopting a resolution in support of a Workforce Housing Tax Incentive Program Application and approving the local match of \$1,000 per housing unit for a total of \$8,000 (in lieu of tax abatement) to be utilized for site development. The resolution was assigned number 6-23-17-1788 and appears in the official resolution book.

Water Tower Equipment Location Lease Extension with AT&T Mobility: Duane shared the proposed cellular antennae space rental lease with AT&T beginning April 1, 2021 and ending March 31, 2051. The Council reviewed the rates. Rod expressed that a 30 year lease is a long time. After some discussion, a motion was made by Council member Rod De Boer and duly seconded by Council member Chad Oolman authorizing Duane to proceed with a lease with AT&T pending a 20 year contract term with the rates as proposed.
