- 1. The meeting will be called to order by Mayor Deb De Haan at 4:30 o'clock P.M.
- 2. Opening ceremonies. Pledge of Allegiance to our flag and a moment of silent prayer.
- 3. The agenda was prepared, posted and distributed in accordance with requirements of the Iowa Open Meeting Act.
- 4. This time is provided for citizen comments.
- 5. The minutes of the January 20, 2020 and January 27, 2020 council meetings are enclosed for your review. Exhibit 1
- 6. The monthly financial report represents cash balances for all funds. Exhibit 2
- 7. A Summary of Warrants report listing bills from January 20, 2020 through February 17, 2020 is enclosed for your review. Exhibit 3
- 8. The public hearing is required for the proposed assessed property owners to be able to visit about the project and their assessments if they want. After the hearing the Council will consider the resolution of necessity. The resolution directing preparation of documents is required even though most of the work has been done to arrive at cost estimates, etc. The resolution ordering bids, plans, specs, and form of contract is to provide the plans to bidders and have a bid opening on March 20 at 10:00 AM and set a public hearing to consider the plans, specs, contract, and estimates on April 6.
- 9. This public hearing is the first of two public hearings that are now required by state code. This public hearing establishes the total maximum property tax dollars and the maximum tax levy for the FY 20/21 for the city. Exhibit 4
- 10. We have presented the General and Utility budgets for Fiscal Year 2020-2021 over the last couple of weeks. See attached Exhibit. We would like to ask for tentative approval and set the second required public hearing for March 2nd. Exhibit 5
- 11. The State Code requires that the Council approve elevations on middle lines of concrete streets periodically for the length of the street. The proposed ordinance establishes those elevations. After approving the first reading, the Council can consider waiving the 2nd and 3rd readings and adopt the ordinance. Exhibit 6
- 12. We have received estimates for painting, repair of kitchen counters, and gutter replacement. We would like to move forward with these items with City Council approval.
- 13. We have received estimates for placing video security systems in several locations. We would like to place these at the compost area, Windmill Park, Veteran's Park, Swimming Pool Park, and Prairie Winds event center.

Council member Steve Roesner entered the meeting at 4:05 o'clock P.M.

Monthly Bills: A Summary of Warrants report listing bills from December 17, 2019 through January 20, 2020 was presented. A motion was made by Council member Rod De Boer and duly seconded by Council member Tony Vande Brake approving the monthly bills, subject to audit. On call of the roll motion carried. The vote was as follows: AYES: Rod De Boer, Tony Vande Brake, Aaron Beadner, Daron De Jong, Steve Roesner; NAYS: None.

Amend R-1 Special Exemption Uses: This is the time and place as advertised to hold a public hearing to consider amending Title 11, Article 3, Definition/Uses Classifications and Article 6, Low Density Residential District, Section 3: Special Exemption Uses. The Council discussed on December 16, 2019 adding "Limited Condominium Residential" as a Special Exemption Use to allow the property recently renovated at 120 Delaware Ave SW by Nic Wielenga to be sold as condominiums. The Mayor opened the time for the public hearing. No one was heard speaking for or against the proposed amendment. Kurt Frederes shared that two letters were received concerning the amendment: Ken Meendering is opposed to the amendment, and Mark Lundberg, representing the Planning and Zoning Commission, expressed he felt he mislead the Council on December 16, 2019 into thinking that the Planning and Zoning Commission members also expressed to Kurt that they were not in favor of the amendment. The Mayor then closed the time for the public hearing.

The ordinance to amend the City Code failed due to a lack of a motion. It was the consensus of the Council to follow the wishes of the Planning and Zoning Commission and not allow the amendment.

Amend Chapter 3, Conditions Regulated, Article 3, Inflammables: This is the time and place as advertised to hold a public hearing to consider amending Chapter 3, Conditions Regulated, Article 3, Inflammables to regulate the maximum size of 1,000 gallons in Commercial/Industrial Districts and 125 gallons in Residential Districts. The Mayor called for

comments from members of the audience and no one was heard speaking for or against the proposed amendment. No written objections were filed. The Mayor then closed the time for the public hearing.
