- 2. Opening ceremonies. Pledge of Allegiance to our flag and a moment of silent prayer.
- 3. The agenda was prepared, posted and distributed in accordance with requirements of the Iowa Open Meeting Act.
- 4. This time is provided for citizen comments. It is suggested that if someone wishes to speak, we also ask for their residence. This time is intended for residents in the City limits.

- 13. The Industrie Centrum 7th Addition will be served by MidAmerican Energy. As part of MidAmerican's policy for providing power, the customer/developer requesting power must fund the infrastructure. We have been working with MidAmerican to provide power to 16th St, the new Hillcrest Apartments, and the new bus barn. The cost for these improvements is estimated to be \$17,640.51. OCDC is working to create a 3.6 acre commercial lot to be made available for sale. OCDC currently owns the property along Highway 10 which used to be the MOC/FV administration building. The City of Orange City owns the property where the MOC/FV bus facility is located and land where Vander Pol Excavating is located. OCDC would like to acquire the bus facility property and 1.5 acres of the former Vander Pol property in order to create the 3.6 acre lot. On call of the roll motion carried. Dutch Front Exemption: Iowa State Bank applied for a Dutch front exemption for their building at 123 Albany Ave SE. The current Dutch front is rotten and is in the process of being removed. Their plan is to make this building compliment their bank building on the corner of Albany Avenue and 1st Street, along with a courtyard area in between the buildings. This remodeling requires an exemption since it is not considered a Dutch front. The Council discussed the investment they are making in the building, they are not looking for matching funds, they were looking for something lower maintenance than wood, they feel the proposed drawings compliment the bank building which is considered Dutch. After some discussion, a motion was made by Council member Tony Vande Brake and duly seconded by Council member Daron De Jong granting a Dutch front exemption for the Iowa State building located at 123 Albany Ave SE. 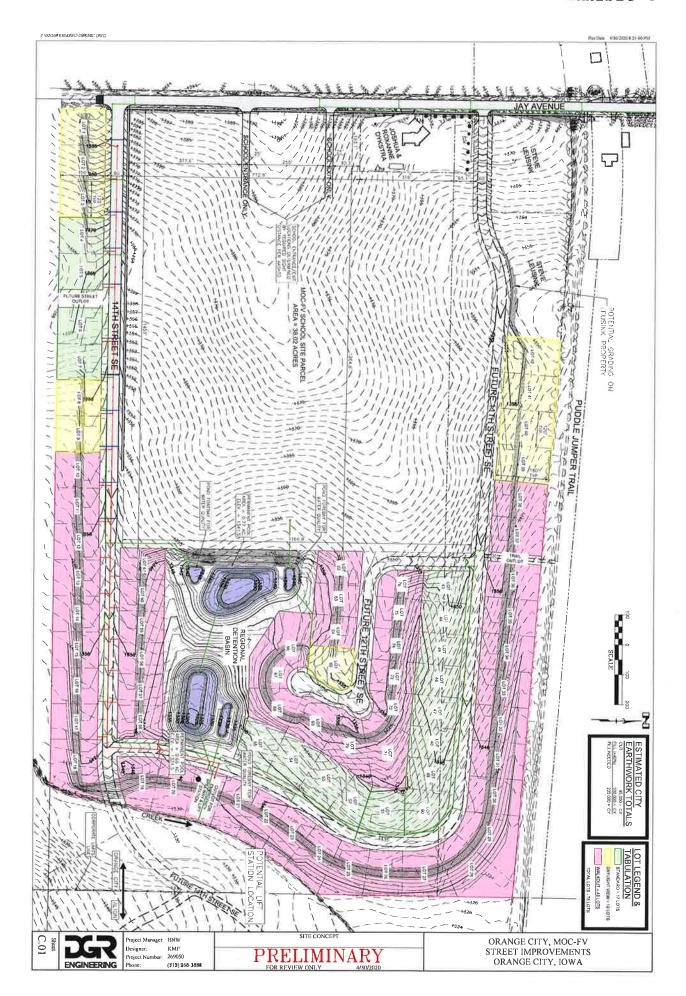

ELECTRIC DISTRIBUTION SYSTEM AGREEMENT REFUNDABLE ADVANCE FOR CONSTRUCTION

MidAmerican Energy Company, an Iowa Corporation, its successors and assigns, (Company), and City of Orange City, its successors and assigns, (Applicant) agree as follows.

- The Company will extend its electric distribution system as required to make electric service available to the following platted and described area: 16
 St SE, Orange City
- 2. The Company shall:
 - a. Install, own, operate and maintain the electric distribution system and reserves the right to extend or alter the system in the future if necessary.
 - b. Furnish all necessary labor and materials required for the construction of such distribution system.
 - c. Schedule such installation with Applicant so as to provide timely service.
- 3. The Applicant shall:
 - Provide, without cost to the Company, such easements as are necessary for the construction, operation and maintenance of the electric distribution system.
 - c. Provide easement areas: 1) cleared of all obstructions; 2) within 4" of final grade over the route of the distribution system; 3) with streets finished to local specifications; and 4) with sewer and water installed.
 - d. Place visible stakes, including lot numbers, on all lot corners and easement lines.
 - e. Provide drawings showing the location of all present and future underground facilities.
 - f. Provide the concrete transformer pads, conduit systems, and other facilities where required by the Company's tariffs and electric service manual (includes an inspection by a Company representative prior to pouring the pads or covering the conduit system).
 - g. Locate all underground facilities such as storm sewers, sanitary sewers, septic lines and water lines that are not located by members of a one-call locating system.
 - h. Indemnify, protect and hold harmless the Company from and against all liability, damage, loss, claims and actions of any nature whatsoever which arise out of damage to underground facilities resulting from the customer's failure to correctly locate such facilities as required under this agreement.
 - i. Hold Company harmless for any loss, cost or damage caused by delays in construction of the distribution system and services
- 4. Applicant agrees to provide a cash advance for construction totaling \$17,640.51. This amount includes \$116,839.65 for construction costs, minus a revenue credit of \$102,100.00, plus the composite Federal and State Tax liability (where applicable) of \$2,900.86. The cash advance for construction shall be due when this Agreement is signed by Applicant. If the estimate or as-built construction costs exceed \$100,000.00, then the Company will require a true-up. If the advance for construction is greater than the as-built construction cost, the Company will refund the difference. The Company reserves the right to collect additional construction costs and applicable taxes from the Customer if the as-built cost exceeds original advance for costruction. If Applicant requires that the installation be completed during the winter construction season, or when adverse working conditions impede construction, Applicant shall pay an additional refundable sum of \$4.96 per foot. Company reserves the right to determine when such winter and/or adverse conditions exist. The amount of the cash advance is subject to change if Applicant's signed acceptance is not received by the Company within 90 days from the date Company executes this Agreement.
- 5. Company will refund portions of the cash advance for construction to Applicant as new customers are added to and connected directly to a point on this electric distribution extension, subject to the following terms:
 - a. An amount equal to 50 percent of annual base revenue for the preceeding year will be refunded at the end of each year for six years, except that the total refund must not exceed the amount of the original advance.
 - b. No interest will be paid on refunded cash advances.
 - c. Refunds will be made at least once a year during the six year period.
- Within the area described above, Company will provide electric service to customers in accordance with Company's tariffs and regulatory requirements.
