- 13. City Council on September 20, 2021, approved the allowable max funds for a Dutch Front for the Scooters Coffee building located at 218 8th St. SE. The final cost for the Dutch front is \$39,335.00 and Council can approve an additional 1%(\$393.35) engineering fee reimbursement. Total reimbursement with engineering fees included is \$20,060.85.
