

ORDINANCE NO. 838

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF ORANGE CITY, IOWA, BY AMENDING CHAPTER 92, WATER RATES

BE IT ORDAINED by the City Council of the City of Orange City as follows:

SECTION 1. That the water rate schedule and use classification provisions of Chapter 92, of the Code of Ordinances of the City of Orange City, Iowa be amended by substituting the following rate schedule:

92.02 RATES FOR SERVICE. Water service shall be furnished at the following rates within the City:

EFFECTIVE JULY 7, 2022

EFFECTIVE JANUARY 5, 2023

RESIDENTIAL:

Customer Charge \$18.00

Customer Charge \$20.00

Volume Charge per 100 cubic feet:
Summer (June-September) \$4.08
Winter (October-May) \$3.03

Volume Charge per 100 cubic feet:
Summer (June-September) \$4.70
Winter (October-May) \$3.65

COMMERCIAL and INDUSTRIAL:

Customer Charge \$24.00

Customer Charge \$26.00

Volume Charge per 100 cubic feet:
Summer (June-September) \$4.08

HIGH VOLUME (average monthly usage over 100,000 cubic feet):

Meters are read and billed monthly.

92.03 RATES OUSTIDE THE CITY. Water service shall be provided to any customer located outside the corporate limits of the City which the City has agreed to serve. No such customer, however, will be served unless the customer has signed a service contract agreeing to be bound by the ordinances, rules and regulations applying to water service established by the Council. (Code of Iowa, Section 364.4 and 384.84)

Water service shall be furnished at the following rates outside the corporate limits of the City:

EFFECTIVE JULY 7, 2022

Customer Charge \$29.50

Volume Charge per 100 cubic feet:

Summer (June-September) \$4.86

Winter (October-May) \$3.81

EFFECTIVE JANUARY 5, 2023

Customer Charge \$30.50

Volume Charge per 100 cubic feet:

Summer (June-September) \$5.20

Winter (October-May) \$4.15

Meters are read and billed monthly.

The rate for customers outside the corporate limits shall apply to all users in metered connections existing outside the corporate boundaries of the municipal corporation of Orange City, Iowa.

SECTION 2. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3. This ordinance shall be in force and effect from and after its passage and publication as provided by law.
